

User's manual for District Nodal Officer

Andhra Pradesh Information Commission (APIC)

This manual explains how to **Authorise the online requests received from District Officers**. The application for Online submission of Annual reports by the District officers. Registration of District Officers is available through Andhra Pradesh Information Commission website at <http://www.apic.gov.in>.

Note: The process of online registration of the District Officer can be referred from the "District Officer" User guide. After registration, the District Officers submit the signed form (Hard Copy) downloaded from the web site to the District Nodal Officer for authentication. Then the process of authentication by the District Nodal officers is as follows.

Go to the APIC Homepage by typing <http://www.apic.gov.in> into the address bar at the top of your web browser (Internet Explorer) and press **enter**. Once the APIC Homepage has loaded, the following screen will be displayed.





This helps the State Information Commission in preparation of a report on the implementation of the provisions of this Act at the end of each year mandated as per section 25(1). Under Section 25(4) a copy of the report of State Information Commission shall be laid before the House of State Legislature.






